

2015 has been quite a year for us at Indwell. In 2013, we made a strategic plan that called for Indwell to double its housing capacity by the end of 2017. But doubling is not just about increasing the number of apartments. Really, it's about doubling the number of people who we are in relationship with, and offering Hope and Homes to them. It's great to report that we are well on track for meeting this goal. This past year we incurred an anticipated operating budget deficit as our four projects in development experienced expenses but did not yet bring in any income.

The need for Hope and Homes continues to grow. While housing and living costs climb rapidly, income for people with a disability remains largely unchanged. Each week we receive about seven new applications from people looking for help. There are currently 470 people who have submitted an application and are waiting for us to provide an affordable home and support.

Our team of staff and volunteers are working hard to meet this growing need, not only in Hamilton and Woodstock, but now also in Norfolk County. We continue to innovate and nuance both our development model and our ongoing programs to meet the challenges of poverty and mental health support needs.

As Indwell becomes known for finding solutions to end homelessness and support people, we think through possible solutions with communities across Ontario. In a typical week, we receive several calls from municipalities, church groups, hospitals, community developers and charities, asking Indwell to help bring Hope and Homes to their community.

At Indwell, we are able to carry out our mission because of the wonderful support of our donor and volunteer community. With your support, we are permanently breaking the cycle of homelessness for hundreds of individuals. However, our work is not done and we need your help to be the hands and feet of Christ to hundreds more people who are seeking Hope and Homes.


### Operating Expenses
